PERMISSION TO BUILD REQUEST

The undersigned hereby applies for a request to build a structure in accordance with the current Licence to Use (LTU).

This request to build is valid from the signed date of the approved Permission to Build Form by the Camp Director and construction/work must be completed within one year from approved date. (Unless otherwise documented by the Camp Director and/or GSW Board.)

A \$25.00 administration fee must be paid at time of request via e-transfer to gswpmts@outlook.com

This application can be emailed to gswmb@shaw.ca **Subject: Permission to Build Request**, or submitted to the Camp Director in person.

Multiple structures cannot be requested on a Permission to Build. For example a deck and a bunky would require separate requests.

The request will not be processed if received without Lot and Structure Plan drawings and construction details. (Separate detailed CAD drawings of the proposed build can be attached)

Please include details of your construction: (examples listed below)

- Wall construction details/materials: I.e.: 2"x4" on 16inch centers with 7/16inch OSB sheathing
- Floor construction details/materials: I.e.: 2"x8" on 16inch centers with 5/8inch T&G sheathing
- Roof construction details/materials: I.e.: 2"x6" rafters, on 24inch centers with blocking, with a max span of 10 feet
- Deck railing details/materials: I.e.: 4"x4" vertical posts with a 2"x6" top plate and balusters spaced on 3 1/2" centers
- Support Beam details/materials: I.e.: 3ply 2"x6" beam with a max span of 8 to 10 feet
I.e.: 2ply 2"x8" beam with a max span of 8 to 10 feet

When considering your structure whether it be a bunky, cabana, deck or shed, please refer to the local building codes, through the Eastern Interlake Planning District website.

To help prevent the request from being denied please ensure you have completed the form correctly and included all necessary details and drawings of the build you wish to complete. Missing information may result in your request being denied and will have to apply again at a later date.

This form is not required if you are building privacy screens, privacy fencing between lots or garden/flower beds. At no point though shall the privacy fencing be installed past the front of the trailer or cabana and hinder access to the Lot. Refer to the LTU for more details.
