TREE CUTTING POLICY

Written permission from the Camp Director is required prior to cutting down trees in excess of 10 centimeters (4 inches) in diameter. These trees are considered mature growth.

PLEASE FOLLOW THESE STEPS AS LISTED BELOW:

- Contact the Camp Director at gswmb@shaw.ca or in person when at the Camp and get a copy of the Tree Cutting Policy & Request form
- Verify the size of the tree by measuring it across the diameter (or its circumference of 12.5 inches)
- Band or flag the trees you wish to cut down
 - ✓ Should only be marked if they conflict with the installation of a trailer or structure being placed or built on the lot
 - ✓ If they could potentially damage trailers and buildings in the event of a windstorm
 - ✓ If they are unhealthy/rotten and could pose a threat to adjacent trailers and buildings
- Once the trees are marked please fill out the Tree Cutting Request Form and submit it to the Camp Director to gswmb@shaw.ca with subject: **Tree Cutting Request**, or in person when at the Camp
- Camp Director will schedule a time to come to the Lot to verify and inspect that the trees do meet the above listed criteria and can be removed
- Depending on the complexity of the job it may be suggested that an arborist is brought in for the tree removal (Tree cutting and disposal is the LTU Holder's responsibility)
- Once the Camp Director has approved that the trees can be cut the submitted request form will be signed off with a copy given to the LTU Holder for record
- **IF THE TREES ARE LESS THAN 10CM (4INCHES) IN DIAMETER**
 - ✓ They may be cut down without approval
 - ✓ Please advise the Camp Director as a courtesy to ensure no issues arise if you are working within the electrical or water lines of the Camp
- **IF TREES OR BRANCHES HAVE FALLEN ON YOUR LOT DUE TO A STORM**
 - ✓ You do not need approval to cut them
 - ✓ You are required to make sure the tree or damaged branches are cut/trimmed and don't pose any potential threat to passersby or prevent access to the Lot
- **REFORESTATION**
 - ✓ for every 1 healthy tree removed, we request that 3 are planted in its place preferably within the lot, or another location as agreed upon with the Camp Director
